## MOTION ONE

#### Proposed by: The Women's Game Network

Women's football has always been an inclusive space that welcomes people from the LGBTQ+ community. As members of the FSA Women's Game Network, we believe the current fixation on debating whether including Trans women in elite sport is 'fair' is a diversion from the real challenges all women footballers face - for secure contracts, equitable working conditions, and adequate pay. It is also creating a hostile environment that compromises the safety and enjoyment of football for Transgender supporters, across the men's and women's games, and hinders progress in building inclusive grassroots leagues.

The Women's Game Network asks the FSA to make an urgent public statement of solidarity with all Transgender footballers and supporters, including non-binary and gender non-forming people, and especially Trans women and trans feminine people, who are the target of heightened discrimination at this time. We wish to do so to clearly communicate our values to the football community, nationally and internationally.

## **MOTION TWO**

We ask that the FSA commit to exploring the optimum path to develop and sustain greater participation and representation of young people in the organisation. In addition, we ask that the FSA explore the best method to support its member supporter organisations and community-owned football clubs in also developing and sustaining greater participation and representation of young people within their structures.

### **MOTION THREE**

### Proposed by West Ham Supporters' Trust

# Seconded by Manchester United Supporters' Trust (MUST)

Many football clubs are entering into partnerships with cryptocurrency providers, including those with product offerings that encourage fans to purchase cryptocurrency backed tokens that provide so called 'engagement opportunities' with their clubs.

It is further noted that cryptocurrencies are a high-risk investment product not currently regulated in the UK.

This motion calls on the FSA is to develop a plan of action to address the proliferation of these schemes across football that includes the following activity:

- Engagement with the Football Association, Premier League and Football League to work collectively on the introduction of common self-regulatory standards for any cryptocurrency partnership entered into by a football club, and to;
- Develop an information awareness campaign for football fans advising them of the risks to their capital of investing in cryptocurrencies

- Lobbying activity to the Government (DCMS and Treasury) to call for the introduction of statutory regulation of cryptocurrency
- Calls upon football clubs that do have partnerships to with cryptocurrency partners to ensure that they undertake due diligence before entering into those arrangements and to meet with the Supporters' Trusts and fans groups to discuss all marketing and promotional activity before it us undertaken to ensure high levels of consumer protection
